1. Minutes of the last meeting

a. CCB approved the minutes from CCB-022 on 17th Sept and CCB-23 on 8th Oct.

2. Meetings Update

- a. JH updated CCB on the 5th November with Surinder Arora (Chairman), Carlton Brown (CFO) from Arora. They outlined the Arora Groups thinking in relation to Heathrow. In return JH described the role and responsibilities of CCB, which at present are limited to scrutiny of HAL as the licence holder and therefore the entity regulated by the CAA.
- b. CCB discussed and agreed content for the meeting with the HAL Executive Board which will take place on the 20th November. At a high level this was that CCB are pleased with the direction of progress, the level of information being presented to CCB and HALs enhanced understanding of consumer engagement coupled with an ability to challenge their own work prior to presenting it to CCB. CCB plan to highlight a few areas of concern, such as the arrivals process, surface access, and external validation of the valuations generated through WTP research.
- c. CCB agreed to use the meeting on the 3rd December to start to formally update the Challenge Log.
